Our Programs

Summer Program

The summer program at Bereskin & Parr serves as an introduction to intellectual property law for students completing their first or second year of law school. Tasks are assigned to students on the basis of educational background, experience, and the special interests of each student. In addition, the firm has a series of training sessions designed specifically for our summer students.

Each student is assigned a mentor who provides him or her with guidance and information, and who works with other professionals in the firm to provide constructive feedback. During the course of the summer term the firm's Professionals Committee will also have discussions with each student regarding his or her progress.

Articling Program

The articling experience at Bereskin & Parr helps students develop practical professional skills in problem recognition, creative problem solving, communications and drafting. We assume that our students are fully capable of managing a significant degree of responsibility, and we ensure that our students have direct client contact from the outset.

Each student is assigned a principal, who ensures that the student is exposed to the required elements of the Law Society Approved Articling Plan, and also serves as a mentor to the student by providing ongoing guidance and feedback. During the course of the articling term the student will also have discussions with the firm's Professionals Committee regarding his or her progress.


Our Programs

Professional Development & Educational Programs

We believe that professional training and continuing legal education are fundamental to a student's success, and are proud to have cultivated comprehensive in-house educational programs that cover a range of intellectual property law subjects and issues.

Internal programs designed specifically for our students include a series of luncheon seminars presented by various professionals in the firm, on subjects that relate to their area of expertise. Students are encouraged to attend regular practice group meetings, which are structured around topical issues specific to certain practice areas. Students may also attend monthly meetings, which include presentations and the review of intellectual property law developments from the preceding month.

At Bereskin & Parr we recognize that the law is constantly evolving and continuing legal education is necessary for even the most seasoned professionals. Accordingly, the firm conducts seminars on trademark law and patent law issues designed to provide professional training to the firm's partners, associates and students.

How to Apply

Candidate Requirements

We look for 1L and 2L candidates who are well-rounded with good academic records, interesting extra-curricular activities, and diverse work experience. As we are committed to providing professional development training and continuing legal education, candidates that we select are team-oriented and interested in making a long-term commitment to our firm.

Application Package Requirements

We require a cover letter, resumé, photocopies of official transcripts from law school, undergraduate, and any other post-secondary education, and a list of upper year courses. Writing samples and reference letters are not required unless otherwise requested.

Your cover letter should be personalized to our firm, describe why you want to work at Bereskin & Parr, and not exceed one (1) page in length. Your resume should include your contact information, education, employment history, volunteer/extra-curricular activities and awards/scholarships, and not exceed two (2) pages in length.

Due Dates and Guidelines

Bereskin & Parr follows the dates and guidelines established by the Law Society of Ontario for the recruitment of students. Students interested in a summer or articling position with the firm should submit their applications via the viDesktop Portal.

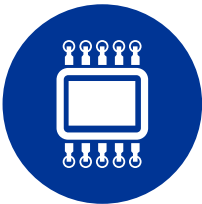

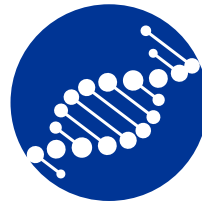

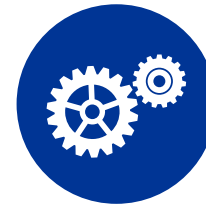
